#### DEALER ELIGIBILITY

To have this promotion as an option on the BryantPromotions.com website, dealer must be enrolled with Bryant Retail Financing Program through Wells Fargo. This requires dealer to have a valid HVACpartners Company ID.

#### DEALER REIMBURSEMENT

Reimbursement will be paid on dealer's Evolution and Preferred volume through the Bryant Retail Financing Program through Wells Fargo Plan 3016. Reimbursement will be provided when claims are submitted through www.BryantPromotions.com by July 15th, 2019.

#### **REIMBURSEMENT PERCENT**

Dealers will be provided a reimbursement equal to 4% of their Wells Fargo cost. Dealers will only receive the reimbursement when using Plan Code 3016 with Evolution and Preferred products.

#### PAYMENT

All reimbursements will be paid monthly by the 15th of the following month. For example, all claims submitted between April 1st and April 30th, 2019, will be paid by Wells Fargo directly to the dealer by May 15th, 2019.
