- Equipment must be verified as eligible at time of sale.
- All systems must be AHRI-matched.
- New York State HVACR License required
- Certificate of Insurance required
- CE Account in good standing (required in order to receive the incentive)

HOW TO CLAIM YOUR REBATE

After submitting a claim for every qualified install - CE will confirm the purchase, Con Edison will verify the install and a credit will be issued by Con Edison to your CE account.

- You will need info about your customer's qualifying job, the CE invoice, and some basic equipment info.
- Rebates will be credited to your CE account from ConEd in about 6 to 8 weeks.
