

How It Works

IT'S SIMPLE: just **ENROLL** and **PURCHASE** qualified, high-efficiency HVAC gas equipment from Carrier Enterprise.

Then **SELL** and **INSTALL** to eligible Con Edison gas heating customers within the service area.



Program Eligibility

- All customers within the Con Edison service territory are eligible (property Zip Code/account # required).
- Equipment must be verified as eligible at time of sale.
- All systems must be AHRI-matched.
- New York State HVACR License required
- Certificate of Insurance required
- CE Account in good standing (required in order to receive the incentive)

Some restrictions may apply. Contractors must notify customers that they are participating in a Con Edison energy-efficiency program.

HVAC Gas Equipment	2019 HVAC Minimum Efficiency Requirement	Incentive
Furnace	$AFUE \ge 94\%$	\$200 per unit
Hydronic Boiler	AFUE ≥ 90%	\$200 per unit
Steam Boiler	AFUE ≥ 82%	\$100 per unit
Indirect Water Heater	Attached to qualifying natural gas boiler	\$75 per unit
Combi-Boiler or Furnace	Boilers AFUE > 90% Furnaces AFUE > 92%	\$325 per unit
Tank Water Heater	Must be ENERGY STAR rated & capacity < 55 gallons; Uniform Energy Factor (UEF) > 0.64 for medium draw pattern, (UEF) > 0.68 for high draw pattern	\$50 per unit
Wi-Fi Thermostats*	Controls natural gas heating equipment	\$25 per unit

* Limit of one thermostat rebate per customer account.

HOW TO CLAIM YOUR REBATE

After submitting a claim for every qualified install - CE will confirm the purchase, Con Edison will verify the install and a credit will be issued by Con Edison to your CE account.

- Once enrolled submit your claims <u>HERE</u> https://midstream-coned-hvac.programprocessing.com
- You will need info about your customer's qualifying job, the CE invoice, and some basic equipment info.
- Rebates will be credited to your CE account from ConEd in about 6 to 8 weeks.

Some restrictions may apply. Contractors must notify customers that they are participating in a Con Edison energy-efficiency program. This program is valid thru 12/31/19 or until funds are exhausted. Incentive amounts are not guaranteed and are subject to adjustment at any time by Con Edison and Carrier Enterprise based on compliance with requirements of the Program, changes in incentive budget, or other factors that may arise during the Program year.
